In India, there are 1.3 million government schools and almost 260 million kids are studying in these schools. 88% of the rural schools don't have hand washing stations and soaps. 56% don't have functioning toilet facilities. More than 60% of rural India is yet to be digitally connected.

Yuva Unstoppable is a 501(c)(3) non-profit which has benefited over 1500 schools and 600,000 underprivileged children across 41 cities of India. 

- * Once the schools are finalised, individual estimate will be made as per requirements schoolwise and hence budget may vary 20-30%.






IMPACT ASSESSMENT

The post survey study for impact assessment for the overall infrastructure upgrade indicated at least a 35% improvement in each of the factors considered for the study.




Improvement of at least 35% in each factor of the overall assessment

A post-survey conducted for 50 schools to measure the overall impact of infrastructure redevelopment. The casual attitude of the children who often remained absent had started to change. The students attendance and willingness to learn increased manifold.



Overall infrastructure standards have improved by 47.06%








ABOUT UDAAN - A PROJECT ON SCHOLARSHIP

According to the government studies, out of 300 million school going age children only about 180 million of them are in schools. 48% of India's children are not enrolled in higher secondary school because of financial problems.

Students who have scored more than 90 percentile or 9 CGPA in their SSC/10th grade or latest exams and has family annual income is less than Rs.3 Lakhs per annum are awarded Rs 25,000/year up to graduation

- ▶ **APPLICATION** Applications are invited through Yuva's online Portal.
- DOCUMENT VERIFICATION Thorough verification of the documents like mark sheet, income certificate, electricity bill, aadhaar, receipts, etc. is done
- > TEST Objective-type screening tests based on SSLC syllabus are conducted
- ▶ INTERVIEW Yuva management team along with the volunteers, personally interviews students who qualify after the screening process
- ▶ SELECTION Final selection is done based on merit, test result and interaction with each student.
- MONITORING & MENTORING Regular mentoring and training sessions are conducted for the students by the donors and various eminent personalities for overall growth and development. Regular counselling for students is conducted for efficient choice of career.
